## Liability & Property Damage Insurance

Often required by event sites, this coverage protects you for damage to the facility and its contents that occurs during your event. It also covers you for bodily injuries that might occur to your guests, or vendors, and for alcohol-related accidents. In most cases, your event site manager will tell you how much coverage to buy to meet their requirements. You should consider adding more if you will be serving alcohol, as you could be held responsible in the event of an alcohol-related accident.

#### SAMPLE Limits & Rates for Private Events (Rates may vary)

One-time Premium with alcohol at event, as low as:	\$150 <b>*</b>	\$175*	\$263*
General Aggregate	\$5,000,000	\$5,000,000	\$5,000,000
Per Occurrence	\$500,000	\$1,000,000	\$2,000,000

## Event Cancellation/Postponement Insurance

If for some reason you had to postpone or cancel your event, such as extreme weather, unexpected illness, withdrawal of military leave, or for other reasons beyond your control, this coverage protects you for lost deposits or non-refundable expenses. It also may protect you for bankrupt or no-show vendors, and replacement of lost, stolen or damaged items.

In most cases, you'll want to choose the level of coverage that most closely matches your total event budget. This is the investment you'd lose if you were forced to cancel or reschedule your event.
